



## 4Life Consent to Electronic Record

E-SIGN, the Electronic Signatures in Global and National Commerce Act (15 U.S.C. § 7001, et seq.), requires that you consent to entering into an electronic agreement with 4Life Research USA, LLC (“4Life”) before an online version of the 4Life Distributor Application and Agreement is entered into. Please read the following information carefully.

Should you enter into an online 4Life Distributor Application and Agreement (“the Agreement”), you will not be required to submit a paper application. The entire agreement between you and 4Life will be evidenced by an electronic record. To enter into the Agreement, you must additionally electronically acknowledge that you agree to the terms of the 4Life Policies and Procedures and the 4Life Marketing and Compensation Plan.

To access these documents and enter into the Agreement, you will need the following hardware and software: A Personal Computer (“PC”) with modem or other Internet access device, operational Internet browser software (e.g., Netscape Communicator or Internet Explorer), and Adobe Acrobat Reader. Should there ever be a change in the equipment or software necessary to access the terms of the Agreement, 4Life will advise you of the same and will provide you with a list of the equipment and software that is necessary. Upon such event, you may withdraw your consent.

Your consent will apply to all transactions between you and 4Life.

You may withdraw your consent to the use of electronic records at any time. However, should you do so, the Agreement will be automatically terminated. During the enrollment process, you will have the ability to read, download, print, and retain the Policies and Procedures and Marketing and Compensation Plan for future reference. Your request must include your name, your Distributor identification number, your mailing address, and your E-mail address. Upon receipt of such a request, 4Life will mail you the then current version of each document. There is no charge for this service.

By entering into the Agreement, you agree that 4Life may amend the same (including the 4Life Policies and Procedures and the 4Life Marketing and Compensation Plan) at its sole discretion at any time. You may obtain a copy of the version of these documents that were in effect at any time after you entered into the Agreement. Prior versions are archived by 4Life. Should you wish to obtain a copy of any version of the 4Life Policies and Procedures and/or the 4Life Marketing and Compensation Plan since the date of your enrollment, send a written request to 4Life, 9850 South 300 West, Sandy, Utah 84070 or an email to [webmaster@4life.com](mailto:webmaster@4life.com). Your request must include your name, your distributor identification number, your mailing address, and your E-mail address. Upon receipt of such a request, 4Life will mail to you a copy of the version of the Agreement that you requested. Be certain to specify the date of the version that you wish to receive. There is no charge for this service. The most current version of the Policies and Procedures and the Marketing and Compensation Plan are always available at 4Life’s official web site for viewing, printing and downloading.

By providing your consent, by checking the box on the preceding enrollment page, you also confirm that you are able to access all the terms of the Agreement electronically.
