TERMS AND CONDITIONS

Builder Bonus

1. Any 4Life distributor at the Builder rank who receives a monthly 100 LP 4Life Loyalty Program order may participate.
2. Loyalty Program orders equaling 100 LP or more, processed in the qualifying month, count toward Builder Bonus requirements.
3. Qualifying orders must be paid for by the distributor (credit card in the name of the distributor listed on the account) and shipped to the primary shipping address listed on the account.
4. A qualifying Loyalty Program order that is returned will result in a retraction of the Builder Bonus earned.
5. To qualify for the \$80 bonus, you must have three qualified (100 Loyalty Program orders) personally enrolled Preferred Customers or distributors on your frontline and a minimum Team Volume of 600 LP. (Team Volume includes your Principal Volume, plus the orders of your frontline Preferred Customers and distributors.)
6. To qualify for the \$320 bonus, you must meet the qualifications for the \$80 bonus. In order to qualify for the \$1,280 bonus, you must meet the qualifications for the \$320 bonus.
7. A distributor may earn either the \$80, \$320, or \$1,280 bonus, but not all three at one time.
8. This bonus is paid monthly, as long as all qualifications are met, and will be added to the distributor's primary commission payment.
9. Builder Bonus program is for markets where 4Life has an office. See separate Terms and Conditions for markets where 4Life does not have an office.

Builder Bonus Pool for Markets Designated by 4Life

1. Any 4Life distributor at the Builder rank who receives a monthly 100 LP order, and resides in a market designated by 4Life (generally markets where 4Life does not have an office), may participate.
2. Orders equaling 100 LP or more, processed in the qualifying month, count toward Builder Bonus pool requirements.
3. Qualifying orders must be paid for by the distributor (credit card in the name of the distributor listed on the account) and shipped to the primary shipping address listed on the account.
4. A qualifying order that is returned will result in a retraction of the Builder Bonus pool earned.
5. Shares for the Builder Bonus pool are earned based upon the level at which you qualify in the Builder Bonus: 1 share for level 1 (\$80 level), 4 shares for level 2 (\$320 level), and 16 shares for level 3 (\$1,280 level). The total LP of the markets designated by 4Life divided by the number of earned shares is used to determine the share values. Share values are not more than \$80 each.
6. To qualify for the \$80 level, you must have three qualified (100 LP orders) personally enrolled Preferred Customers or distributors on your frontline and a minimum Team Volume of 600 LP. (Team Volume includes your Principal Volume, plus the orders of your frontline Preferred Customers and distributors.)
7. To qualify for the \$320 level, you must meet the qualifications for the \$80 level. In order to qualify for the \$1,280 level, you must meet the qualifications for the \$320 level.
8. A distributor may earn either the \$80, \$320, or \$1,280 level, but not all three at one time.
9. The Builder Bonus pool is paid monthly, as long as all qualifications are met, and will be added to the distributor's primary commission payment.
10. The Builder Bonus pool is for markets designated by 4Life (generally where 4Life does not have an office). See separate Terms and Conditions for markets where 4Life has an office.
