4Life tests our products for banned substances in the following categories: (1) performance enhancing drugs in sports nutrition products, (2) erectile dysfunction drugs (i.e., PDE-5 inhibitors) and structural analogs in sexual vitality products, as well as (3) stimulants, diuretics, laxatives, etc. in weight management products. See below for the specific list of tested 4Life products.

Additionally, all products are shipped to the laboratories un-opened and with tamper-evident seals in place.

ANALYTICAL REPORT - 2303017

Reason for Analysis: Banned Substances Control Group (BSCG) was contracted to perform testing on several items for the presence of anabolic steroids and other related compounds.

Receiving: On March 9, 2023, a package was received intact with no signs of tampering at our ISO 17025 accredited laboratory partner. The package contained six items identified as follows:

<u>Analytical Method:</u> Samples of the items were extracted and analyzed for anabolic steroids and other related compounds according to in-house methods for nutritional supplements by ultra-high-performance liquid chromatography / high-resolution mass spectrometry (UHPLC/HRMS). The testing menu included the list of compounds on page two. Method detection levels, which vary based on matrix analyzed, are estimated to be in the 2-500 ng/g range for most compounds in most supplement items.

<u>Analytical Findings:</u> No compounds in the testing menu were detected in the items.
