



# THE 4LIFE 25<sup>th</sup> ANNIVERSARY “SILVER SUMMER GIVEAWAY” TICKET CONTEST TERMS AND CONDITIONS

The **4Life 25<sup>th</sup> Anniversary** contest (the “**Contest**”) is organized by 4Life Research, LLC (the “**Contest Sponsor**”). The Contest begins on July 21, 2023 (the “**Contest Opening Date**”) and ends on August 31, 2023 (the “**Contest Closing Date**”).

## 1. ELIGIBILITY

The Contest is open to individuals who have reached the age of majority in their country of residence by the Contest Opening Date, except for employees; agents; mandataries and representatives of the Contest Sponsor; its subsidiaries; affiliates; affiliated companies; advertising or promotion agencies; the suppliers of material, prizes, and services related to this Contest; and any other stakeholder directly related to the holding of the Contest, as well as the members of their immediate family (father, mother, brothers, sisters, children, and legal or de facto spouse) and anyone with whom these employees, representatives, and agents reside.

Each scratch card contains one (1) scratch section (“Scratch”) that contains information to learn what your prize is and how to redeem it. To claim your prize, refer to instructions which follow under General Rules, but to be eligible, all prize claims must be redeemed by September 30, 2023.
