

How to do Business in Vietnam via Thailand

How to Enroll?

- 1. Complete this Affiliate Application & Agreement Form with digital signature
 - Copy of passport
 - Personal Vietnam or Thailand Bank Account
 - Please fill out bank details in the Affiliate Application & Agreement Form
- 2. Submit the required documents via email to <u>vietnam@4life.com</u>. The 4Life Thailand team will process your application.

After enrollment, Thailand Customer Service will send the new Affiliate their 4Life ID number and 4Life login information via email.

How to Place an Order?

Place an order via email by using this <u>Order Form</u> Steps:

- Send the order form (link) to <u>vietnam@4life.com</u>
 - OR Call Customer Service at +66(0)2-460-7068 (English language available upon request)
- Then, log into 4Life Thailand website and pay directly for your purchase.

Shipping and Fees to Vietnam

- Each order to Vietnam must not exceed \$10,000 (which includes shipping fee of \$850 + 7% VAT)
- Package will be shipped via Thai Post's Express Mail Service (EMS)
- Shipping to Vietnam takes about 14 days
- Package will be shipped to Inward Office Exchange in Vietnam
- Customers will need to pay a fee of import duty tax levied by the Vietnam Customs upon picking up the package



How are bonuses paid to 4Life Affiliates?

- 1. Bonuses are stored in your 4Life AR account. Funds can be used from your AR to buy products directly from 4Life. May use up to 100% of order value to pay for product order.
- 2. When funds are below \$5,000:
 - If a foreigner can establish a Thai bank account, we can send commissions directly to this account up to twice per month.
 - Wire transfer fee to Thai bank account is levied to the customers at \$10 or \$12 per transaction, depending on the bank.
 - Payment of the commission from the previous month will be made by 20th of the following month. If these dates fall on a national or public holiday, the payment will be made 2-3 working days earlier.
- 3. When funds exceed \$5,000:
 - 4Life can facilitate international wire transfers. Wire transfers to Vietnam banks have fees levied to customers at \$1,350 per transaction.
- For foreigners who stay in Thailand over 180 days, the Thailand office must automatically deduct 15% withholding tax and submit to Revenue Department on their behalf.
- The bonus payout rate is USD 1 = \$37.
