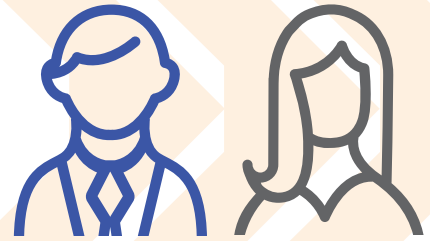

Terms and Conditions



- In order to receive a Rank Advancement bonus, Direct sellers must qualify at a new high rank during the qualifying period in May, June, or July 2021.
- Direct sellers must advance at the rank of Builder Elite or higher.
- Direct sellers can only earn a Rank Advancement bonus one time at each new rank.
- Direct sellers who advance to Builder Elite will earn a one-time bonus of Rs. 2250/-.*
- Direct sellers who advance to Diamond will earn a one-time bonus of Rs. 4500/-.*
- Direct sellers who advance to Diamond Elite will earn a one-time bonus of Rs. 11250.*
- Direct sellers who advance to Presidential will earn a one-time bonus of Rs. 22500/-.*
- Direct sellers who advance to Bronze will earn a one-time bonus of Rs. 45000/-.*
- Direct sellers who advance to Bronze Elite will earn a one-time bonus of Rs. 90000/-.*
