How to Place an Order

1. Place your order through 4life website www.4life.com/korea
2. Place your order via fax at +82-2-552-0828 or +82-2-6442-8004
3. Place your order via phone at +82-2-553-8007
4. Order in person at Korea office or Busan office. Products can be picked up at the store there, or shipped for free if you order more than 66,000KRW total.
5. Order payments can be made either cash or credit cards. Any faxed order payments by credit card must attach a copy of the front and back of the card for verification.
6. Shipping will be free if the total order is more than 66,000KRW.

How Commissions are Paid Out

- Wired to your Korean bank account that is on your application form.
- If a distributor believes any errors have been made regarding commissions, the distributor must notify 4Life within 30 days of the commission payment day.
- Commission will be revised not to overpay beyond legal standards based on the article 20.3 of Korean multilevel marketing industry law.
